## FEE SCHEDULE

### New Patient Visits

**Pre-Consult.....FREE**  
Includes either a phone or face-to-face meeting with the doctor to ensure a good therapeutic fit. This does not include discussion of any specific health concerns. This will last a maximum of 15 minutes.

**Acute care.....\$115.00**  
Includes an assessment of a single acute problem and immediate treatment or referral, as appropriate. These visits generally require 15-20 minutes. <sup>99202</sup>

**Short Initial visit.....\$165.00**  
Suitable for a single health concern. Includes any necessary examinations, assessment, and recommendations for appropriate testing and treatment options. This generally involves a single problem, usually with initial treatment, and requires about 30 minutes. <sup>99203</sup>

**Standard Evaluation\*.....\$250.00**  
Suitable for one or two chronic health problems. Includes a detailed evaluation of the patient's past medical and family medical history, a review of body systems, dietary evaluation, physical examination, and laboratory testing recommendations, as appropriate. This evaluation generally includes initial treatment, and requires approximately 45 minutes. <sup>99204</sup>

**Comprehensive evaluation.....\$315.00**  
Suitable for multiple chronic or complex health problems. Includes a detailed evaluation of the patient's past medical and family medical history, a review of body systems, dietary evaluation, physical examination, and laboratory testing recommendations, as appropriate. This evaluation generally includes initial treatment, and requires approximately 60 minutes. <sup>99205</sup>

### Return Patient Visits

**Brief office visit .....\$70.00**  
Suitable for assessment of an acute problem and immediate treatment or referral, as appropriate. May also be used for brief review of lab results. These visits generally require 10-15 minutes. <sup>99212</sup>

**Short Standard Office Visit.....\$110.00**  
Suitable for evaluation of treatment progress and non-complex new complaints. Includes physical examination, referrals, and laboratory testing when appropriate. These visits generally require 15-20 minutes. <sup>99213</sup>

**Long Standard Office Visit\*.....\$165.00**  
Suitable for evaluation of treatment progress and slightly more complex new complaints. Includes physical examination, referrals, and laboratory testing when appropriate. These visits generally require 25-30 minutes. <sup>99214</sup>

**Reevaluation Visit..... \$220.00**  
Suitable for stalled treatment progress and need for fresh evaluation or new complex health issues not yet evaluated. Includes physical examination, referrals, and laboratory testing when appropriate. These visits generally require 40-45 minutes. <sup>99215</sup>

**Extra Time Charge (per 30 minute increments)..... \$150.00**

\*Standard Evaluation and Long Standard Office Visit are the most commonly used billing codes.\*
